VIOLATION NOTICE

On December 5, and December 10, 2016, the Michigan Department of Environmental Quality (MDEQ), Air Quality Division (AQD), investigated complaints regarding nuisance odors alleged to be the result of operations at the Arbor Hills Landfill located at 10690 Six Mile Road, Northville, Michigan. The purpose of these investigations was to determine if this facility is in compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, and Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules promulgated pursuant to these parts; and to investigate complaints of alleged nuisance odors received on December 5, and December 10, 2016.

Staff of the AQD performed the investigations and observed the following air pollution and solid waste violation:

Municipal solid waste landfill owned and operated by Advanced Disposal Services; a landfill gas collection and control system owned and operated by Republic Services Inc. which is a subsidiary of BFI Waste Services of North America; and a gas to energy plant owned by Fortistar Methane Group	R 336.1901(b), R 299.4433(1)(c)	AQD staff observed moderate to strong (Level 3 to 4) landfill gas-like odors.

During the investigations performed on December 5, and December 10, 2016, AQD staff detected landfill gas odors in the Steeple Chase subdivision downwind of the facility. These odors were traced back to Arbor Hills Landfill. The observed landfill gas odors are a violation of Rule 901(b). The Rule 901 (b) violation also constitutes a violation of Rule 433(1)(c) since the gases generated by the facility created a nuisance odor beyond the property boundary.

Since the first of this year, MDEQ staff has received over 500 odor complaints regarding Arbor Hills Landfill. In response to complaints and repeated observations of offsite odors, MDEQ staff has conducted numerous on-site inspections and complaint investigations in the immediate area. Though MDEQ staff has documented offsite odors of garbage, compost, and other waste streams, the predominant odors and primary odors of concern continue to be landfill gas. These most recent observations of landfill gas like odors in violation of Rule 901 and Rule 433(1)(c), appear to indicate the landfill gas collection and control systems are inadequate. While the MDEQ recognizes the efforts taken to date to resolve offsite odors, these recent observed odor violations indicate more work needs to be done to minimize landfill gas odors from the facility.

The MDEQ encourages all parties to work cooperatively and immediately to resolve any and all offsite odor issues, but especially the landfill gas odors referenced in this violation. Please submit a written response to this Violation Notice by December 23, 2016, (which coincides with 8 calendar days from the date of this letter).

The written response should include:

- 1. The dates the violation occurred;
- 2. An explanation of the causes and duration of the violation;
- 3. Whether the violation is ongoing;
- 4. A summary of the actions that have been taken to correct the violation;
- 5. A summary of the actions that are proposed to be taken to correct the violation;
- 6. The dates by which these actions will take place; and
- 7. What steps are being taken to prevent a reoccurrence.

In recognition of the ongoing enforcement and associated collaborative corrective action plan requested by the United States Environmental Protection Agency (USEPA), the MDEQ also encourages a joint response from all parties. This response shall include a detailed comprehensive facility-wide work plan with construction schedules that all parties have agreed upon to upgrade the gas collection and control system sufficiently to bring the landfill back into compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, and Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451), and the administrative rules.
